- 4.2 Coaches: All coaches must have a minimum Comp Intro Trained as per standards set by the Canadian Snowboard Federation LTAD 3. Coaches and managers must have a Criminal and Vulnerable Sector Record check. Coaches must complete the Respect in Sport on-line training program.
- 4.3 Exclusions: In districts where there is not a Comp Intro Trained coach a Comp Intro Coach who has completed the CS Comp Intro course and is in Training may be approved by the PTL.

9.0 TIE BREAKING PROCEDURE:

In the final, should a tie occur, dual medals are awarded

10.0 SPORT PROTEST PROCEDURE:

Protests are decided by the Jury (Head Judge, Event Director, Provincial Coach). A protest fee of \$25 applies and is refunded if the protest is successful.

Snowboard, helmet (as per CS standards – CASA certified), mouth guards are recommended but not required.
